Solicitor swore in Mr. Robinson with Applicant Robinson placing his name and address on the record. (Chandler seated for Hitchner/Valente seated for Eachus)

Solicitor placed on the record that he received and reviewed the Proof of Notification and has approved same. Solicitor stated the application was deemed for completeness at the Jan 18, 2023 meeting for Bulk Variance. Solicitor further advised that the Minor Subdivision that was approved last year, as a condition of approval, those Deeds are to be finalized and recorded prior.

Applicant Robinson advised the Board that he wants to construct a 1500 sf pole barn for storage, two garage doors that would face into the property. He also wants to install solar panels on the roof of the pole barn.

Miller asked what setbacks applicant is seeking. (Planner Scheule advised the Board that the required rear yard and side yard setback is 30 ft from the property line). Applicant is seeking a variance of 20 ft rear yard and side yard setback.

Professional McKelvie asked applicant if he was intending to regrade the property, to which applicant stated that he does not intend to regrade. Professional McKelvie therefore suggested that the applicant provide a proposed grading plan. Professional
